NOTICE

Sub.: Implementation of the Contributory Post-Retirement Medical Assistance Scheme (CPRMAS).

- The Corporation has implemented the Contributory Post-Retirement Medical Assistance Scheme (CPRMAS) for its retired employees as per Office Circular (OC) No. PL-IR/Post Retirement Medical Benefit/2021/563 dated 01.07.2021, Revised OC No. PL/IR/Post Retirement Medical Benefit/2021/795 dated 08.09.2021, and OC No. PL/IR/Post Retirement Medical Benefit/2021/72 dated 14.01.2022.
- 2. As per Clause 2(1)(i) of the Scheme, the eligibility for the scheme extends to the Pensioner and his/her Spouse. The package limit applies to both individuals (i.e., Wife and Husband) combined. If both individuals were employed by DVC, they will be covered under a single credit limit as per the stated clause.
- 3. Contributions for the scheme are recovered annually in April from the pension as per Clause 4(4.2) of the CPRMAS. Employees retired under the National Pension System (NPS) and Contributory Provident Fund (CPF) must deposit the requisite amount as specified in the scheme, according to Clauses 4(4.1) and 4(4.3).
- 4. If the yearly contribution for the year 2024-25 was mistakenly recovered in April/May 2024 from ineligible pensioners, please inform the Pension Section, HQ for necessary rectification/refund of the recovered contribution.
- 5. Similarly, if contributions were mistakenly recovered from both pensioners (i.e., Wife and Husband), please inform the Pension Section, HQ for necessary record updates and refunds. If the yearly contribution of CPRMAS was inadvertently recovered from family pensioners other than the spouse, the amount will be refunded upon intimation to the Pension Section, Kolkata.
- Furthermore, if a double credit limit was inadvertently used in cases where both husband and wife are DVC pensioners, or if the CPRMAS treatment facility was availed by a family pensioner other than the spouse by mistake, the entire amount utilized will be recovered from the respective pensioners.

Therefore, all concerned pensioners are requested to submit the Declaration in the attached format (Annexure-I) within 21 days from the date of issue of this Notice/Circular to the Pension Section, DVC, Kolkata through the email id dvcpension@gmail.com or by post/speed post.
