OFFICE MEMORANDUM

Corporation vide O.M. No. GL/MFP/84-89/99(Pt.)/546 dt. 01.04.05 has granted a fixed medical allowance of Rs. 100/- (Rupees one hundred) only per month to all those DVC Pensioner/ Family Pensioner who are not availing OPD facilities at DVC Hospital/Dispensaries. For the purpose of making payment of the said allowance, an 'OPTION' in the Prescribed form is required to be furnished by the beneficiaries. The said option form (enclosed) may please be given wide circulation among the existing pensioner/family pensioners.

The filled in 'OPTION FORMS' are required to be sent to the Pension Disbursing Authorities concerned of DVC formation & Head Quarters, Kolkata by the beneficiaries who are drawing pension from those sources. Pensioners/family Pensioners who are drawing pension though Public Sector Bank & Post Office are required to send the filled in 'OPTION FORMS' to the Pension Section, Kolkata.

Pension disbursing authorities of DVC formation and Pension section, Kolkata shall initiate payment action upon receipt of the filled in Option Form.
