CCL management has also urged DVC BTPS management to take immediate measure so that water supply may not be hampered. In above backdrop the level of both intakes started decreasing drastically on 08.08.2024 as deposition of slit in the forebay of both intakes occurred due to said flash flood and as a result sufficient water level is not getting maintained for continuous operation of intake pumps. As there is no contract in hand to take up this emergent requirement of said work. It is directed to immediately engage an experienced, reliable and resourceful agency.
