Dear Sir,

i) WHEREAS, Contract for "Rate Contract for Hiring of 1( one) number Dozer having Engine capacity 310- 325 HP with Coal Blade attachment for feeding of coal to Reclaim Hopper, and other works as per Scope of Work, for Coal Handling Plant, U#7&8, CTPS, DVC" were awarded to M/s MANOJ KHEMKA, Rani Bazar, Katrasgarh, Dhanbad above was issued by Damodar Valley Corporation.

ii) WHEREAS, several communications were held with you under reference (5) to (11) above regarding unavailability of dozer and final notice was served to you under reference (2) above for submitting the reason within 30 days after receiving the letter that why your contract should not be terminated.

WHEREAS, you have not resumed your work and replied that, the deployed dozer is having technical problem and is not suitable to work for long term also you have not found any suitable replacement. You expressed your inability to continue the work and have requested for release from the contract as per final notice served under ref. (2).

iii) THEREFORE, as per the provision of the subject contract (Clause no 24.2.2 (b) of GCC i.e. "Termination for Contractor's Default") and documents and documentary evidence available in support thereof, the subject contract under ref. (4) has been terminated vide no. DVC/Contract/Head Quarter/CHP (M) U# 7 and 8/CMM/Works and Service/00009/CC\_1 Dated 02/04/2025 on your default, with immediate effect.

iv) In view of above, we are constrained to take the decision of suspension of business dealings with your firm initially for a period of 03 (three) months from the date of issue of this intimation. You may note that during the said period, you shall not be allowed to participate in any tender enquiry in any of the Projects/Stations of DVC and in case you have participated in the tender process but price bids are yet to be opened, your bids will be rejected. In addition to the above, you shall not be allowed to participate as an Associate for any of the tenders of DVC.

v) Please note that the suspension of business dealings shall be without prejudice of any rights of DVC and in addition to our rights to take such further actions at our discretion as are warranted in this regard at your sole risk as to the costs and consequences.
