DEBARMENT ORDER

Dear Sir.

Whereas The Purchase Order under reference-1 was placed to you. However, you could not execute the supply as per the terms and conditions of the Purchase Order. Further, you repeatedly failed to make suitable replies to repeated communications made by DVC and also failed to resolve the aforesaid issues. Despite several reminders through email (Ref.-3,4, 5,6,7,) you failed to supply.

As per T&C 5(iii) of PO. DVC/Contract/RTPS/Water Package Maintenance/C&M Purchase & Contract/Supply/00033 Dated 31/08/2019 "the Purchaser may cancel the Order/contract completely or partly without prejudice to his right under the alternatives mentioned above"

Accordingly, the subject purchase order was cancelled by DVC vide under ref.-2 dated-13/05/2024.

As per the corporation's rule, a show cause notice was issued through the registered post as well as an email sent to you vide letter no. RTPS/DVC/C&M/SHOW CAUSE/1021 DATED 21/12/2024 in which you were asked to submit your representation on the case, But no reply has been received against the above show cause notice issued to you within the stipulated time. As per W&P manual "In case no reply to show cause notice is received within the stipulated time, appropriate speaking order for debarment shall be passed exparte."

So as per the corporation's rule, debarment of 01 year if "Does not supply material or supplies material of inferior quality or work executed is of poor quality which is not as per the Technical Specifications of the Contract" is applicable in this case.

In view of the above, we are constrained to take the decision to debar your firm for a period of one (01) year from the date of issue of this order, You may note that during the said period, you shall not be allowed to participate in any tender enquiry in any of the projects/stations of DVC and in case you had participated in any tender process, and price bids are yet to be opened your bid shall not be considered.

Please note that your debarment shall be without prejudice of any rights of DVC and in addition to our rights to take such further actions at our discretion as are warranted in this regard at your sole risk as to the costs and consequences.

This issue is with the approval of the competent authority and in the interest of the Corporation's work.
