Debarment/ Banning of all your business dealing with DVC.

Dear Sir,

- i) WHEREAS, Contract for "Fabrication and installation of extra screen filter in series of existing screen filter of CT basin of CTPS unit7&8, Chandrapura for a period of 01 year" was awarded to M/s S.O.P. Engineering Works ("Contractor") by Damodar Valley Corporation ("DVC") against the work order under reference (1) above for awarded value of Rs. 4,37,800.00 (Rs. One Lakh Thirty Seven Thousand Eight Hundred Only) excluding GST@ 18%.
- ii) WHEREAS, communications were held with you vide letter under reference (3) & (4) above regarding your failure to execute the work and non-compliance of terms & conditions as per the contract.

It was intimated you that if you fail to submit the sufficient reason and justification within 30 days' notice period raised through letter under reference (4) above, subject contract shall be terminated and penal action may be taken against you by DVC for wilful violation of contractual obligations, as per terms of the Contract.

WHEREAS, you had not replied against our several email vide letter under reference (3) & (4) above.

THEREFORE, as per the provision of the subject contract (Clause no. 31 of contract & Clause no. 24 of GCC) i.e. "Termination Clause" and documents and documentary evidence available in support thereof, the subject contract under ref. (5) has been terminated vide no. DVC/Contract/CTPS/BOP(M) U#7 and 8/C&M/Works and Service/00043/CC_1 Dated :29.05.2024 on your default, with immediate effect.



And a show cause notice for banning/debarment of business dealings was served to you vide ref. (6' above in line with the provisions contained in the Contract to furnish reply within 30 days from the date of issuance of this notice as to why you will not be debared/banned from business dealing.

In response the notice served vide show cause notice dated 29.05.2024 as cited under ref. (6), no reply had received against our show cause notice from your end.

You have abandoned the work and breach the contract, and it is clear violation of code of integrity for public procurement.

- i) In view of the above, we are constrained to take the decision of <u>debarment/ banning of business dealings</u> with your firm for a period of one (01) year from the date of issuance of this intimation. You may note that during the said period, you shall not be allowed to participate in any tender enquiry in any of the Projects/Stations of DVC and in case you have participated in the tender process, but price bids are yet to be opened, your bids will be rejected. In addition to the above, you shall not be allowed to participate as an Associate for any of the tenders of DVC.
- ii) Please note that the <u>debarment/ banning of business dealings</u> shall be without prejudice of any rights of DVC and in addition to our rights to take such further actions at our discretion as are warranted in this regard at your sole risk as to the costs and consequences.
