NOTICE FOR DEBARMENT

Sub.: Tender for "Up-keepment & cleaning works of DSTPS Powerhouse Unit#1&2 including various plant buildings and its surrounding roads at DSTPS, DVC, Andal."

 - 2) Show cause notice for debarment was issued vide No. DVC/DSTPS/Up keepment/GEM/2024/B/4744812/088 dated 08.08.2024
 - 3) Incident further escalated by DVC in GeM vide no. 1932632 dated 19.07.24.
 - 4) Incident raised by DVC in GeM vide no. 1932632 dated 16.07.24.
 - 5) Your email dated 09.07.24 regarding your inability to execute the contract in case of award at your quoted rate in GeM.
 - 6) Tender No.: GEM/2024/B/4744812 Dated:11/03/2024.

Dear Sir,

- 1. A Tender for "Up-keepment & cleaning works of DSTPS Powerhouse Unit#1&2 including various plant buildings and its surrounding roads at DSTPS, DVC, Andal." was issued on open tender with e reverse auction basis in GeM vide no. GEM/2024/B/4744812 Dated:11/03/2024.
- 2. After techno commercial evaluation of bids and subsequent opening of price bid in GeM on 05.07.24 and subsequent conclusion of e reverse auction in GeM on 09.07.24, it was found that, you emerged as L1 bidder. The rate quoted by you is Rs. 2,39,08,845/- (Two Crore thirty-nine Lacs eight thousand eight hundred forty-five) only inclusive of GST.
- 3. Subsequently, you were requested to submit price breakup against your quoted price and for submission of notarized documents against subject tender vide email dated 09.07.24 as per provisions of clause no. 3 of Terms and Conditions and as per ITB of additional terms and

conditions of GeM bid. However, you vide email dated 09.07.24 have expressed your inability to execute the contract in case of award at your final quoted rate after e reverse auction in GeM.

- 4. Therefore, an incident vide no. 1932632 dated 16.07.24 was raised in GeM portal, which was further escalated on 19.07.24.
- 5. In view of the above, as per IFB of GeM bid and clause no. B.1(a) of Debarment policy of General Condition of Contract as attached in Buyer added terms and condition of GeM bid, a show cause letter for debarment vide no .DVC/DSTPS/Upkeepment/GEM/2024 /B/4744812/088 dated 08.08.2024 was issued, wherein you were given an opportunity to explain in writing within a period of 30 days from date of issue of notice why DVC should not debar you for one year as per the terms and conditions of the aforesaid GeM bid.
- 6. In response to our show cause letter for debarment, you have replied vide email dated 23.08.24.
- 7. The whole array of documents and correspondence as have been brought on record have been examined in detail for arriving at a conclusion in the matter. Further your reply through email dated 23.08.24 has been taken into consideration in entirety on its merit. After due consideration and appreciation of the entire gamut of issues involved, it is conclusively proved and established beyond reasonable doubt, that you, M/s. Tulshi Das Mukherjee have expressed your inability to execute the contract in case of award at your final quoted rate after e reverse auction in GeM several times. Despite several requests and notices, there has been no further effort on your part to submit price breakup against your quoted price and for submission of notarized documents against subject tender. Your said conduct has vitiated the process of the tender and caused financial loss to DVC.
- 8. Accordingly, DVC is constrained to debar your firm from participating in any tender, enquiry in any of the Projects/Stations of DVC for a period of one year from the date of issue of this intimation. You may note that during the said period, you shall not be allowed to participate in any tender enquiry in any of the Projects/Stations of DVC and in case you have participated in the tender process but price bids are yet to be opened, your bids will be rejected. In addition to the above, you shall not be allowed to participate as an associate for any of the tenders of DVC.

Please note that the banning of business dealings shall be without prejudice and in addition to our rights to take such further actions at our discretion / as may be advised /as are warranted in this regard / DVC rules and regulations and/or applicable law, at your sole risk as to the costs and consequences.
