 Whereas, You have been awarded WO No. DVC/Contract/KTPS/Water Pkg. incl. Fire system/C&M Purchase & Contract/Works and Service/00030 Dated 20/09/2021 (For "Hiring of one(01) no. vehicle hard top Jeep like Bolero, Scorpio, Sumo, non-A/C Diesel driven engine of any reputed make like Mahindra, Tata etc. for official use of Operation Section, KTPS, DVC for round the clock (24 hrs.)" subject to further authorisation and satisfactory performance with same rate, terms and conditions. ) & WO No. DVC/Contract/KTPS/Water Pkg. Fire system/C&M Purchase & Contract/Work and Service/00027; Date 18/09/2021 (For "Hiring of 01 (one) no. of vehicle (Bolero/Scorpio/sumo) non-AC Diesel of any reputed make Like TATA, Mahindra etc. for use of CISF personnel, DVC, KTPS for round the clock duty (24 Hrs.) for a period of 02 (Two) years" subject to further authorisation and satisfactory performance with same rate, terms and conditions.)

- You have withdrawn the vehicle of Operation Section on 09/09/2023 and CISF Personnel on 14/03/2023 without given any intimation to DVC.
- 3. In spite of several reminders through email and registered post (ref. 3,4,5,6,7,8,9) to mobilize the vehicle immediately for trouble free power generation. You did not respond in both the cases.
- As per provision of the Sl. No.11 under Terms and Condition of WO DVC/Contract/KTPS/Water Pkg. incl. Fire system/C&M Purchase & Contract/Works and Service/00030 (Termination for Contractor's Default) and the documents available in support thereof, the WO were terminated.
- As per Corporation 's rule, a show cause notice was issued through registerd post which was returned as well as sent email to you vide letter No. KT/DGM (C&M)/24-25/147 dated 06/08/2024 in which you were asked to submit your representation on the cases. But, No reply has been received against the above show cause notice issued to you within the stipulated time. So as per Corporation's rule, debarment of 01 year if "Vendor fails to achieve or complete the contract milestones with the time schedule stipulated in the contract" is applicable in this case.
- 6. In view of the above, We are constrained to take the decision to debar your firm for a period of one (01) year from the date of issue of this order. You may note that during the said period, you shall not be allowed to participate in any tender enquiry in any of the projects/ stations of DVC and in case you had participated in any tender process, and price bids are yet to be opened your bid shall not be considered.
- Please note that your debarment shall be without prejudice of any rights of DVC and in addition to our rights to take such further actions at our discretion as are warranted in this regard at your sole risk as to the costs and consequences.

This issue with the approval of the competent authority and in the interest of Corporation work.
